The overview contains a breakdown of the received data, as well as the missing or incomplete elements.

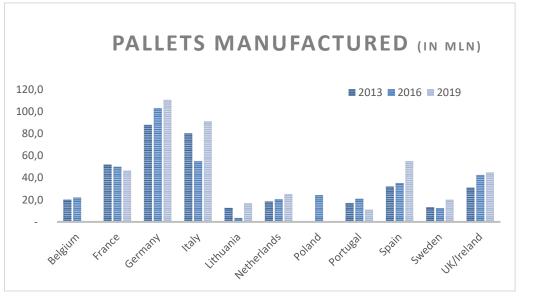

PALLETS MANUFACTURED AND REPAIRED

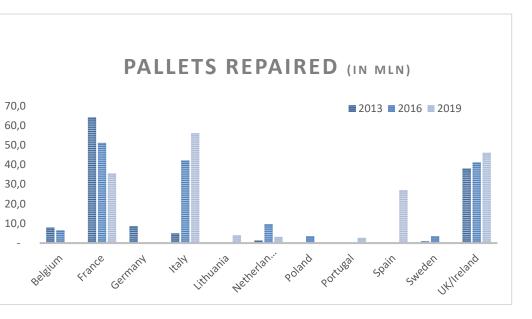
Of these reporting countries, we can analyse how many new units were manufactured within the participating markets in 2019. These datapoints are then presented in reference to the 2016 and 2013 reports, and take note of a steady increasement of new units manufactured.

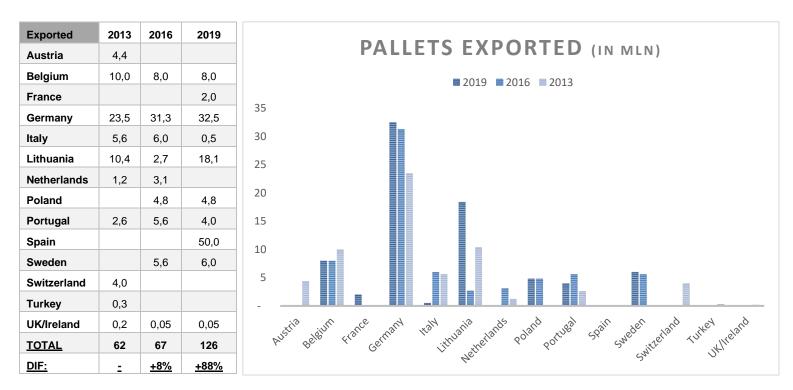

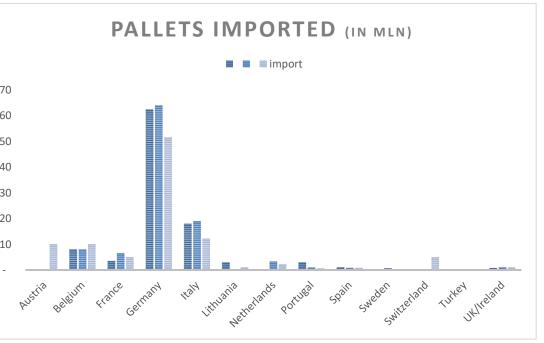

PALLETS EXPORTED AND IMPORTED

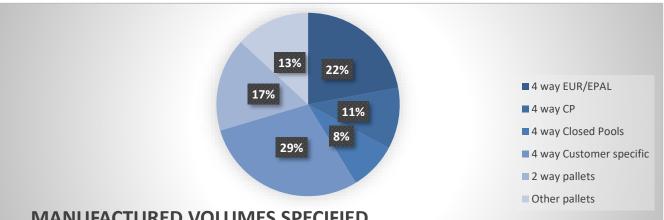

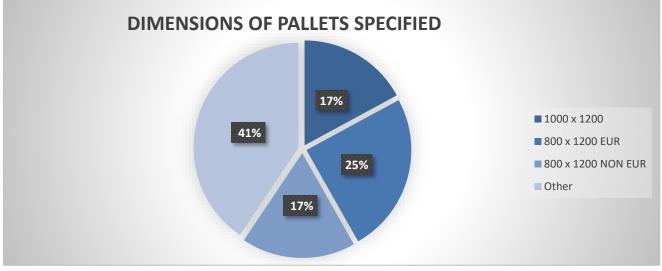


BREAKDOWN OF VOLUMES SPECIFIED

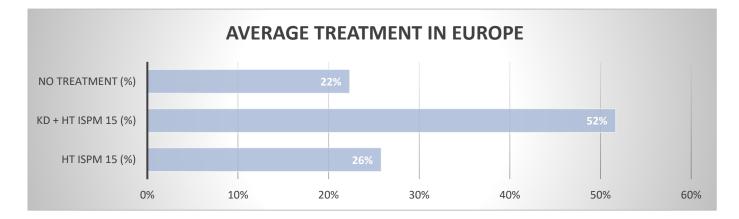

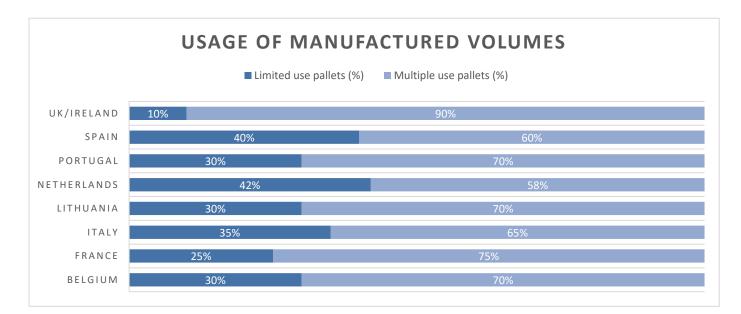

VOLUMES RELATED TO TREATMENTS AND USAGE

Of these reporting countries, we can review the treatments applied to the wooden packaging material and compare to previous years. It can be noted that the KD+HT ISPM 15 method gained popularity as we noted a 45% average over the reporting year of 2016. This difference was gained from what was previously noted as HT ISPM 15 treated materials.



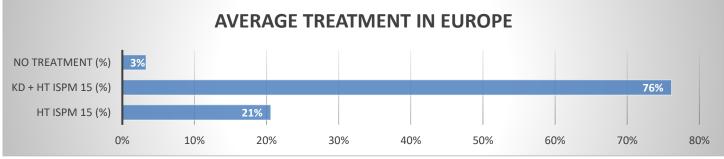
Of the reporting countries, we can take note of the limited use, or multiple use of pallets. It's worth mentioning that all pallets are reusable, unless it concerns packaging that is intended to be deployed only once before it enters the waste phase. We noticed a large increasement of what is reported as multiple use on the European market. These numbers were averaging around 50-50 in 2013.

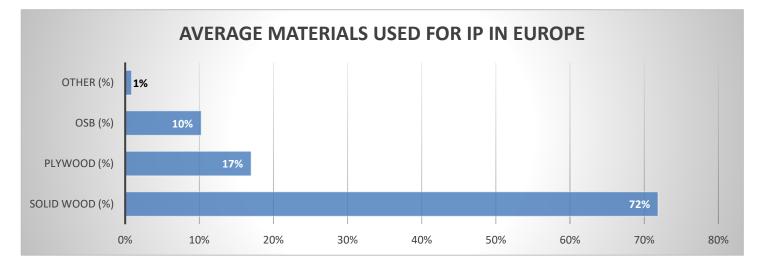


INDUSTRIAL PACKAGING TURNOVER COMPARISON

Of these reporting countries, we can also distil how much the Industrial Packaging section produced. The results are more difficult to display since units produced are hardly standardised. Therefore the annual turnover of the market is measured. The results compared between 2019, 2016 and 2013 can be reviewed below. A steady increasement can be noted in total addressable market. Below that graph we can note that the average treatment is almost completely aligned with ISPM 15, as 3% is reported to have no treatment whatsoever.

Of the lightweight packaging section we can report that the total manufactured market increased by 14% between 2016 and 2019. Most notable where the 1billion units produced in France. This is related to the small packaging, such as cheese boxes, which are specific to the market.

OVERVIEW OF THE EUROPEAN EFFORTS ON PACKAGING WASTE

The European Union rules on packaging and packaging waste to cover both the production, design and waste management of all packaging materials and aim to deal with the increasing quantities of waste which cause environmental problems. This means all materials, and packaging including industrial, commercial, household and other sectors. They also aim to remove barriers in the internal EU market, caused by EU countries adopting different rules on packaging design.

Although the EU considers the implementation of these rules to be a success, they note the amount of packaging waste in the EU is still increasing, and that too many of our finite resources are being wasted without being recirculated into the economy.

The EU has revised and amended its laws on packaging several times. It is with this in mind that FEFPEB seeks to create a representative European market overview from which it can initiate further endeavours to inform and assist policy makers in Brussels to harmonise the implementation, and set realistic industry targets for recycling which include repair for reuse calculations.

The latest amendment to the Directive contains updated measures to prevent the production of packaging waste and promote the reuse, recycling and other forms of recovering of waste, instead of its final disposal. Among other rules, by end of 2024, EU countries should ensure that producer responsibility schemes are established for all packaging. The Directive also sets the following specific targets for recycling on all packaging and specific materials.
